2.21 We first note that the classes are not of equal length. If the distribution of the data were uniform over a single interval covering all of the data, one would expect that longer classes would have higher counts. To correct for this, the area of each rectangle should be proportional to the proportion of observations in the class. Of course, when the class lengths are equal, plotting the height equal to the class frequency results in rectangles with area proportional to the corresponding class proportions.

2.54 (a) We can estimate the mean and the median in this case since we know the class marks and frequencies for each class.
(b) We cannot estimate the mean in this case, since we do not know the class marks for the classes "less than 90 " and "more than 119". We can estimate the median. It lies in the third class, and we proceed as before.
(c) Again, we cannot estimate the mean since we do not know the class mark for the class " 110 or less". We also cannot estimate the median, as it also lies in the class "110 or less".
2.55 (a) There are 50 observations. $Q_{1}$ is in the second class and $Q_{3}$ is in the 4 th class. The lower class boundary for the 2 nd class is 245 . There are 3 observations in the first class and 11 in the 2 nd class. The class interval is 40 . Thus, $Q_{1}$ is estimated by $40(50 / 4-3) / 11+245=279.55$
Proceeding in a similar fashion gives $325+40(37.5-37) / 9=327.22$ as the estimate of $Q_{3}$. Thus, the interquartile range is 47.67 .
(b) There are 80 observations and $80 / 4=20$ which is on the boundary of the second and third classes so the estimate for $Q_{1}$ is 3.00 and for $Q_{3}$ it is $1((60-52) / 10+6.00=6.80$.
