## Electric Forces

1. For a contact force, the two objects must touch. For example, normal, tension, spring, friction, drag, and buoyant forces. All of these are actually macroscopic manifestations of the electromagnetic force.

For a field force, they do not need to touch and force can exist at large separation distances. Gravity is an example.
2. Franklin said that the electric force was due to the electric fluid and when there is excess fluid, the object is positive. Hence, he did not have a particle model in mind.
3. $N=\frac{q}{e}=\frac{35 \times 10^{-9} \mathrm{C}}{1.6 \times 10^{-19} \mathrm{C} / \text { proton }}=2.2 \times 10^{11} \mathrm{protons}$
4. We first estimate the number of electrons in the plate. Assume it weighs around 4 ounces or 0.1 kg . It's likely made of some polymer, but let's just assume it's something carbon-based, for instance. In that case,

$$
N_{\text {tot }}=100 \mathrm{~g}\left(\frac{1 \mathrm{~mol}}{12.0 \mathrm{~g}}\right)\left(6.02 \times 10^{23} \frac{\text { atoms }}{\mathrm{mol}}\right)\left(6 \frac{\text { electrons }}{\text { atom }}\right) \approx 3 \times 10^{25} \text { electrons }
$$

Using Eq. 23.2, the number of excess electrons is

$$
N_{\text {excess }}=\frac{q}{-e}=\frac{-75 \times 10^{-6} \mathrm{C}}{-1.6 \times 10^{-19} \mathrm{C} / \text { electron }}=4.7 \times 10^{14} \text { electrons }
$$

Keeping only one significant figure because we were estimating, the fraction of excess charges is then

$$
\frac{N_{\text {excess }}}{N_{\text {tot }}}=\frac{4.7 \times 10^{14} \text { electrons }}{3 \times 10^{25} \text { electrons }} \approx 2 \times 10^{-11}
$$

5. Divide the total charge by the charge of a single electron to determine the number of electrons.

$$
N=\frac{q}{-e}=\frac{-1.00 \mathrm{C}}{-1.60 \times 10^{-19} \mathrm{C} / \text { electron }}=6.25 \times 10^{18} \text { electrons }
$$

6. The amount of charge transferred is found by multiplying the number of electrons transferred by the charge of a single electron.

$$
\Delta q=\left(5.00 \times 10^{9}\right)\left(-1.60 \times 10^{-19} \mathrm{C}\right)=-8.00 \times 10^{-10} \mathrm{C}
$$

Then, the remaining charge of the sphere is found by adding this charge to the sphere's initial charge.

$$
Q_{\text {sphere }}=8.05 \times 10^{-9} \mathrm{C}+\left(-8.00 \times 10^{-10} \mathrm{C}\right)=7.25 \times 10^{-9} \mathrm{C}
$$

Then, the remaining charge of the rod is found by subtracting the charge transferred from the rod's initial charge.

$$
Q_{\mathrm{rod}}=-6.03 \times 10^{-9} \mathrm{C}-\left(-8.00 \times 10^{-10} \mathrm{C}\right)=-5.23 \times 10^{-9} \mathrm{C}
$$

7. (a) The rod has lost mass. Electrons have been stripped from the rod, leaving behind a net positive charge.
(b) Using Eq. 23.1, the number of electrons lost is

$$
N=\frac{q}{e}=\frac{45.7 \times 10^{-6} \mathrm{C}}{1.60 \times 10^{-19} \mathrm{C} / \text { electron }}
$$

The mass lost is then

$$
m=\left(\frac{45.7 \times 10^{-6} \mathrm{C}}{1.60 \times 10^{-19} \mathrm{C} / \text { electron }}\right)\left(9.11 \times 10^{-31} \mathrm{~kg}\right)=2.60 \times 10^{-16} \mathrm{~kg}
$$

8. Based on Problem 7, the scarf gained about $10^{-16} \mathrm{~kg}$ of electrons. Assuming it has a mass of around 0.1 kg , this is a fractional increase of only $10^{-15}$, which of course would not be noticeable.
9. (a) The excess charge is equal to the number of electrons times the charge per electron $e$.

$$
N=\frac{q}{e}=\frac{-4.20 \times 10^{-6} \mathrm{C}}{-1.60 \times 10^{-19} \mathrm{C}}=2.63 \times 10^{13} \text { electrons }
$$

(b) We can then compare this to the total number of electrons by determining the number of atoms in 50.0 g of aluminum times the number of electrons per atom.

$$
50.0 \mathrm{~g} \mathrm{Al}\left(\frac{\mathrm{~mol}}{27.0 \mathrm{~g}}\right)\left(6.02 \times 10^{23} \frac{\text { atoms }}{\mathrm{mol}}\right)\left(13 \frac{\text { electrons }}{\text { atom }}\right)=1.45 \times 10^{25} \text { electrons }
$$

Dividing by the answer to part (a) to get the desired fraction,

$$
\text { fraction of electrons lost }=\frac{2.63 \times 10^{13}}{1.45 \times 10^{25}}=1.81 \times 10^{-12}
$$

(c) Multiply the number of electrons removed by the mass of the electron.

$$
\left(\frac{-4.20 \times 10^{-6} \mathrm{C}}{-1.60 \times 10^{-19} \mathrm{C}}\right)\left(9.11 \times 10^{-31} \frac{\mathrm{~kg}}{\text { electron }}\right)=2.39 \times 10^{-17} \mathrm{~kg}=2.39 \times 10^{-14} \mathrm{~g}
$$

10. (a) When your socks rub the carpet, you build up extra electric fluid which is then transferred to the doorknob when you touch it.
(b) When your socks rub the carpet, electrons are transferred, and you either gain or lose electrons. When you touch the doorknob, excess electrons are then transferred to or from the doorknob.
11. Yes. When silk and glass are rubbed, they become oppositely charged. Similarly, the wool and plastic are oppositely charged. Therefore, if glass and plastic attract (are oppositely charged), then the silk and wool must also be oppositely charged and will attract.
12. When you rub on the seat, you gain or lose electric fluid, which is transferred to the gas pump like lightning. If we think of this fluid as a current of electrons, our explanations are the same.
13. Rubber is an insulator and prevents electrical discharge or shocks.
14. The chopstick will be attracted to the charged object because there will be an induced polarization due to the formation of dipoles at the microscopic scale.
15. We calculate the number of electrons and the surface area of the sphere, using the results to calculate the number density.

$$
\begin{aligned}
& N=\frac{q}{e}=\frac{-36.3 \times 10^{-9} \mathrm{C}}{-1.60 \times 10^{-19} \mathrm{C} / \text { electron }}=2.27 \times 10^{11} \text { electrons } \\
& A=4 \pi r^{2}=4(3.14)(0.0435 \mathrm{~m})^{2}=0.0238 \mathrm{~m}^{2} \\
& \frac{N}{A}=\frac{2.27 \times 10^{11}}{0.023 \mathrm{~m}^{2}}=9.54 \times 10^{12} \mathrm{~m}^{-2}
\end{aligned}
$$

16. The charges will be divided evenly and each will have a final charge of $+15.0 \mu \mathrm{C}$, regardless of how contact is made.
17. The charges will not move easily and would not easily be transferred between the two objects. So the charged insulator retains a net charge of $+30.0 \mu \mathrm{C}$, and the other retains a net charge of 0 . However, it does matter how the contact is made. If either of the insulators is moved while they are in contact, such that a friction force acts on each insulator over a short distance, charges can be transferred from one to the other.
18. The negatively charged insulating plate induces a polarization on the conductor, with a net positive charge of the bottom. The connection to ground then allows the negative charge on top to drain, leaving a net positive charge on the conductor.

19. The amount of charge might decrease, but any charge will be distributed around the entire conductor surface at the end.
20. (a) When the positively charged object is brought close to the electroscope, it becomes polarized, leaving a net positive charge at the bottom. The two rods are positively charged and repel, causing the moveable rod to rotate away.

(b) Without the positive charge polarizing the electroscope, the charge on the platform returns to the bottom. The neutral electroscope is then uncharged as it was initially.
(c) When the negatively charged object is brought close, the electroscope polarizes in the opposite way as in part (a), leaving a net negative charge at the bottom. Since the two rods are negatively charged, they again repel, and the moveable rod rotates away from the fixed one.

(d) Charge is transferred to the electroscope, causing it to have a net charge even when the object is removed. The moveable rod will rotate away from the fixed one.
21. (a) Using Coulomb's law (Eq. 23.3),

$$
\begin{aligned}
& |F|=\frac{k\left|q_{1} q_{2}\right|}{r^{2}} \\
& F=\frac{k_{e} e^{2}}{r^{2}}=\frac{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(5.50 \times 10^{-9} \mathrm{C}\right)\left(8.95 \times 10^{-9} \mathrm{C}\right)}{(3.00 \mathrm{~m})^{2}}=4.92 \times 10^{-8} \mathrm{~N}
\end{aligned}
$$

(b) The charges are opposite charges. The force is attractive.
22. Applying Coulomb's law (Eq. 23.3),

$$
\begin{aligned}
& F_{E}=\frac{k\left|q_{1} q_{2}\right|}{r^{2}} \rightarrow \quad r=\sqrt{\frac{k\left|q_{1} q_{2}\right|}{F_{E}}} \\
& r=\sqrt{\frac{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(34.5 \times 10^{-9} \mathrm{C}\right)\left(54.3 \times 10^{-9} \mathrm{C}\right)}{2.70 \times 10^{-4} \mathrm{~N}}}=0.250 \mathrm{~m}
\end{aligned}
$$

23. Applying Coulomb's law (Equation 23.3), we solve for $q$ and insert numerical values.

$$
\begin{gathered}
F_{E}=\frac{k q^{2}}{r^{2}} \\
q=\sqrt{\frac{F_{E} r^{2}}{k}}=\sqrt{\frac{(2.3)\left(1.5^{2}\right)}{8.99 \times 10^{9}}}=2.4 \times 10^{-5} \mathrm{C}
\end{gathered}
$$

Each coin must have the same charge for the force to be repulsive.
24. Equation 23.5 is

$$
\overrightarrow{\boldsymbol{F}}_{[1 \text { on 2] }}=\frac{k q_{1} q_{2}}{r^{2}} \hat{\boldsymbol{r}}
$$

where $\hat{r}$ points from Particle 1 to 2 . If the charges are either both positive or both negative, the calculated value will be positive, and the force on 2 due to 1 points away from Particle 1, i.e. is repulsive (see Fig. 23.23). If they have opposite signs, the calculated value will be negative, so the force will have a direction opposite the unit vector and the force on Particle 2 will be towards 1.
25. According to Eq. 23.3, the force depends on the inverse square of the separation, so if the force is 4 times larger, the separation must be half of the original value, $r_{i} / 2$.
26. (a) The force is attractive since the particles have opposite charges.
(b) The distance $r$ in Coulomb's law is the distance between the particles. The magnitude of the force is (Eq. 23.3)

$$
F=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(25.0 \times 10^{-6} \mathrm{C}\right)\left(15.0 \times 10^{-6} \mathrm{C}\right)}{(0.550 \mathrm{~m})^{2}}=11.1 \mathrm{~N}
$$

27. The electric force on each particle will be equal in magnitude but opposite in direction. The magnitude of the force is given by Eq. 23.3.

$$
F=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.75 \times 10^{-9} \mathrm{C}\right)\left(2.88 \times 10^{-9} \mathrm{C}\right)}{(0.0825 \mathrm{~m})^{2}}=6.66 \times 10^{-6} \mathrm{~N}
$$

Note that both particles have a positive net charge. Thus, they will repel each other. So (a) the force on the $2.88-\mathrm{nC}$ particle will be $6.66 \times 10^{-6} \hat{\imath} \mathrm{~N}$, and (b) the force on the $1.75-\mathrm{nC}$ particle will be $-6.66 \times 10^{-6} \hat{\boldsymbol{i}} \mathrm{~N}$.
28. The magnitude of the electric force between the particles is initially given by

$$
F_{\text {initial }}=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.75 \times 10^{-9} \mathrm{C}\right)\left(2.88 \times 10^{-9} \mathrm{C}\right)}{(0.0825 \mathrm{~m})^{2}}
$$

The final electric force should be twice as much, so we use Eq. 23.3 again and solve for the new charge separation distance, $r$.

$$
\begin{aligned}
& F_{\text {final }}=2 F_{\text {initial }} \\
& \left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.75 \times 10^{-9} \mathrm{C}\right)\left(2.88 \times 10^{-9} \mathrm{C}\right)}{r^{2}}= \\
& 2\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.75 \times 10^{-9} \mathrm{C}\right)\left(2.88 \times 10^{-9} \mathrm{C}\right)}{(0.0825 \mathrm{~m})^{2}} \\
& \frac{1}{r^{2}}=2 \frac{1}{(0.0825 \mathrm{~m})^{2}} \\
& r=0.0583 \mathrm{~m}
\end{aligned}
$$

29. (a) Use Eq. 23.3 to express the initial electric force between the particles.

$$
F_{E}=\frac{k\left|q_{1} q_{2}\right|}{d^{2}}
$$

Now, use the same equation to solve for $r$, where the electric force magnitude would be halved.

$$
\begin{aligned}
& F=\frac{1}{2} F_{E} \\
& \frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\frac{1}{2} \frac{k\left|q_{1} q_{2}\right|}{d^{2}} \\
& \frac{1}{r^{2}}=\frac{1}{2 d^{2}} \\
& r=d \sqrt{2}
\end{aligned}
$$

(b) Use Eq. 23.3 to solve for $r$, where the electric force magnitude would be doubled.

$$
\begin{aligned}
& F=2 F_{E} \\
& \frac{k\left|q_{1} q_{2}\right|}{r^{2}}=2 \frac{k\left|q_{1} q_{2}\right|}{d^{2}} \\
& \frac{1}{r^{2}}=\frac{2}{d^{2}} \\
& r=d / \sqrt{2}
\end{aligned}
$$

30. The attractive electrostatic force between the electron and the positively charged nucleus is the centripetal force keeping the electron in orbit. Setting the Coulomb force (Eq. 23.3) equal to the centripetal force, we can then solve for the speed, $v$.

$$
k \frac{Z e^{2}}{r^{2}}=m \frac{v^{2}}{r} \quad \rightarrow \quad v=\sqrt{\frac{k Z e^{2}}{m r}}
$$

31. (a) Using Coulomb's law (Eq. 23.3),

$$
F_{E}=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\frac{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(\left|-1.60 \times 10^{-19} \mathrm{C}\right|\right)^{2}}{\left(5.00 \times 10^{-11} \mathrm{~m}\right)^{2}}=9.21 \times 10^{-8} \mathrm{~N}
$$

(b) We calculate the gravitational force and then take the ratio, which is huge, as we would predict.

$$
\begin{aligned}
& F_{g}=\frac{G m_{1} m_{2}}{r^{2}}=\frac{\left(6.67 \times 10^{-11} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(9.11 \times 10^{-31} \mathrm{~kg}\right)^{2}}{\left(5.00 \times 10^{-11} \mathrm{~m}\right)^{2}}=2.21 \times 10^{-50} \mathrm{~N} \\
& \frac{F_{E}}{F_{g}}=\frac{9.21 \times 10^{-8} \mathrm{~N}}{2.21 \times 10^{-50} \mathrm{~N}}=4.16 \times 10^{42}
\end{aligned}
$$

32. (a) The charges will be distributed equally, so each ball will have charge.

$$
(5.0+15.0) / 2 \mu \mathrm{C}=10.0 \mu \mathrm{C} \text {. }
$$

(b) The charge $q_{1}$ increases by a factor of 2 while the charge $q_{2}$ decreases by a factor of $2 / 3$. Since the Coulomb force (Eq. 23.3) depends on the product $q_{1} q_{2}$, the force increase by a factor of

$$
(2)(2 / 3)=4 / 3=1.33
$$

33. We use Coulomb's law to calculate the electrostatic force and Newton's law of gravitation to find the gravitational force between the balls and then determine the charge when they are equal.

$$
\begin{aligned}
& k \frac{\left|q_{1} q_{2}\right|}{r^{2}}=G \frac{m_{1} m_{2}}{r^{2}} \\
& \left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{q^{2}}{(1.0 \mathrm{~m})^{2}}=\left(6.67 \times 10^{-11} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{kg}^{2}\right) \frac{\left(5.0 \times 10^{-3} \mathrm{~kg}\right)\left(5 \times 10^{-3} \mathrm{~kg}\right)}{(1.0 \mathrm{~m})^{2}} \\
& q^{2}=0.19 \times 10^{-24} \mathrm{C}^{2} \\
& q= \pm 4.3 \times 10^{-13} \mathrm{C}= \pm 0.43 \mathrm{pC}
\end{aligned}
$$

34. The electric force on $q_{A}$ (found using Eq. 23.3, Coulomb's law) is balanced by the spring force $(F=-K x)$, where $K$ is the spring constant (to avoid confusion with the constant $k$ in Coulomb's law).

$$
\begin{gathered}
\frac{k\left|q_{\mathrm{A}} q_{\mathrm{B}}\right|}{d^{2}}=K x \\
x=\frac{k\left|q_{1} q_{2}\right|}{K d^{2}}=\frac{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(2.00 \times 10^{-6} \mathrm{C}\right)\left(3.60 \times 10^{-6} \mathrm{C}\right)}{(125 \mathrm{~N} / \mathrm{m})(0.120 \mathrm{~m})^{2}}=0.0360 \mathrm{~m}=3.60 \mathrm{~cm}
\end{gathered}
$$

35. We relate the equal-magnitude charges on both spheres to the electrostatic force (Eq. 23.3) and solve for $q$.

$$
F_{E}=k \frac{\left|q_{1} q_{2}\right|}{r^{2}}=k \frac{q^{2}}{r^{2}}
$$

$$
q=r \sqrt{\frac{F_{E}}{k}}=(0.750 \mathrm{~m}) \sqrt{\frac{1.00 \times 10^{5} \mathrm{~N}}{8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}}}=2.50 \times 10^{-3} \mathrm{C}
$$

The number of electrons transferred is then

$$
N=\frac{q}{e}=\frac{2.50 \times 10^{-3} \mathrm{C}}{1.60 \times 10^{-19} \mathrm{C} / e^{-}}=1.56 \times 10^{16} \text { electrons }
$$

The total number of electrons in each sphere is

$$
N_{\mathrm{tot}}=\left(\frac{25.0 \mathrm{~g}}{63.5463 \mathrm{~g} / \mathrm{mol}}\right)\left(6.022 \times 10^{23} \text { atoms } / \mathrm{mol}\right)\left(29 e^{-} / \text {atom }\right)=6.87 \times 10^{24} e^{-}
$$

The fraction transferred is then

$$
f=\frac{N_{\text {xfer }}}{N_{\text {tot }}}=\left(\frac{1.56 \times 10^{16}}{6.87 \times 10^{24}}\right)=2.28 \times 10^{-9}
$$

or two out of every billion electrons.
36. Yes. If the other two charged particles have opposite signs and the closer particle has less charge, the forces on the end particle due to these particles may be equal and opposite, leading to zero net electrostatic force.
37. Note that both particles will exert a force on the $5.00-\mathrm{nC}$ particle that is directed to the left, or in the $-x$ direction. Use Eq. 23.3 to find the electric force of the $-10.00-\mathrm{nC}$ particle on the $5.00-\mathrm{nC}$ particle.

$$
\begin{aligned}
& F_{-10.00}=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(\left(-10.00 \times 10^{-9} \mathrm{C}\right)\left(5.00 \times 10^{-9} \mathrm{C}\right) \mid\right.}{(0.0350 \mathrm{~m})^{2}} \\
& F_{-10.00}=3.67 \times 10^{-4} \mathrm{~N} \\
& \overrightarrow{\boldsymbol{F}}_{-10.00}=-3.67 \times 10^{-4} \hat{\boldsymbol{i}} \mathrm{~N}
\end{aligned}
$$

Then, use Eq. 23.3 to find the electric force of the $3.00-\mathrm{nC}$ particle on the $5.00-\mathrm{nC}$ particle.

$$
\begin{aligned}
& F_{3.00}=\frac{k\left|q_{1} q_{2}\right|}{r^{2}}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left|\left(3.00 \times 10^{-9} \mathrm{C}\right)\left(5.00 \times 10^{-9} \mathrm{C}\right)\right|}{(0.0150 \mathrm{~m})^{2}} \\
& F_{3.00}=5.99 \times 10^{-4} \mathrm{~N} \\
& \overrightarrow{\boldsymbol{F}}_{3.00}=-5.99 \times 10^{-4} \hat{\boldsymbol{i}} \mathrm{~N}
\end{aligned}
$$

Finally, use the principle of superposition to find the net electric force.

$$
\overrightarrow{\boldsymbol{F}}_{\text {net }}=\overrightarrow{\boldsymbol{F}}_{-10.00}+\overrightarrow{\boldsymbol{F}}_{3.00}=\left(-3.67 \times 10^{-4} \hat{\boldsymbol{i}}-5.99 \times 10^{-4} \hat{\boldsymbol{i}}\right) \mathrm{N}=-9.66 \times 10^{-4} \hat{\boldsymbol{i}} \mathrm{~N}
$$

38. First, use the geometry of the figure to find the distance between the $5.65-\mu \mathrm{C}$ particle and each of the others.

$$
\begin{aligned}
& d_{10.33}=\sqrt{(-0.0200 \mathrm{~m}-0.0100 \mathrm{~m})^{2}+(0.0100 \mathrm{~m})^{2}} \\
& d_{10.33}^{2}=1.00 \times 10^{-3} \mathrm{~m}^{2} \\
& d_{-15.12}=\sqrt{(-0.0200 \mathrm{~m})^{2}+(0.0100 \mathrm{~m})^{2}} \\
& d_{-15.12}^{2}=5.00 \times 10^{-4} \mathrm{~m}^{2}
\end{aligned}
$$

Then, use Eq. 23.3 to find the magnitude of the electric force between each of the particles and the $5.65-\mu \mathrm{C}$ particle.

$$
\begin{gathered}

\end{aligned}

(b) The two original charges have been replaced by a single point charge with the same net charge.

64. The toughest part is estimating the weight of the hair. For instance, assume several strands of hair is about 2 g (the mass of a paperclip) and that the distance is around an inch (or 3 cm ). Taking the Coulomb force as equal in magnitude to the weight and assuming a point charge model, we calculate a charge of around 40 nC . Estimates could vary based on the assumptions made.
65. The forces acting on each sphere are tension, electrostatic (Coulomb), and gravitational. Since the sphere is in static equilibrium, the net force is zero. Considering the vertical component first,

67. Three forces are acting on each sphere: gravitational force, electrostatic force, and tension in the string as shown for Sphere A. The net force on the sphere is zero:

$$
\sum \overrightarrow{\boldsymbol{F}}=\left(T \sin 30^{\circ}-k \frac{q^{2}}{r^{2}}\right) \hat{\boldsymbol{i}}+\left(T \cos 30^{\circ}-m g\right) \hat{\boldsymbol{j}}=0
$$

Considering each component separately,

$$
\begin{align*}
& T \sin 30^{\circ}=k \frac{q^{2}}{r^{2}}  \tag{1}\\
& T \cos 30^{\circ}=m g \tag{2}
\end{align*}
$$

Dividing equation (1) by (2) and solving for $q$,

$$
\begin{aligned}
& \tan 30^{\circ}=\frac{k q^{2}}{m g r^{2}} \\
& q= \pm r \sqrt{\frac{m g \tan 30^{\circ}}{k}} \\
& q= \pm(0.10 \mathrm{~m}) \sqrt{\frac{\left(2.00 \times 10^{-3} \mathrm{~kg}\right)\left(9.81 \mathrm{~m} / \mathrm{s}^{2}\right) \tan 30^{\circ}}{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)}} \\
& q=1.12 \times 10^{-7} \mathrm{C}
\end{aligned}
$$

68. The third sphere is in static equilibrium, so the forces due to the other charges are equal and opposite.

$$
k \frac{\left|q_{1} Q\right|}{r_{1}^{2}}=k \frac{\left|q_{2} Q\right|}{r_{2}^{2}} \rightarrow \frac{q_{1}}{r_{1}^{2}}=\frac{q_{2}}{r_{2}^{2}}
$$

Based on the figure,

$$
\begin{gathered}
r_{1}=x_{0} \quad \text { and } r_{2}=L-x_{0} \\
\frac{q_{1}}{\left(x_{0}\right)^{2}}=\frac{q_{2}}{\left(L-x_{0}\right)^{2}} \rightarrow\left(\frac{L-x_{0}}{x_{0}}\right)=\sqrt{\frac{q_{2}}{q_{1}}} \rightarrow x_{0}=L\left(\sqrt{\frac{q_{2}}{q_{1}}}+1\right)^{-1}
\end{gathered}
$$

Finally inserting $q_{1}=4 e$ and $q_{2}=e$.

$$
x_{0}=L\left(\sqrt{\frac{e}{4 e}}+1\right)^{-1}=\frac{2}{3} L
$$

The third charged sphere is closer to the sphere with the smaller charge, as we would expect.

69. Charge $q$ resides on each of the blocks, which repel as point charges. We use Coulomb's law (Eq. 23.3) and Hooke's law (with spring constant, $K$ ):

& \sum F_{y}=F_{\mathrm{A}}+F_{T} \cos 30^{\circ}-F_{g}=0
\end{aligned}
$$

Using the first equation,

$$
\begin{aligned}
& k \frac{q_{\mathrm{B}} q_{1}}{r_{\mathrm{B}}^{2}}=F_{T} \sin 30^{\circ}=0 \\
& q_{1}=\frac{r_{\mathrm{B}}^{2} F_{T} \sin 30^{\circ}}{k q_{\mathrm{B}}}=\frac{(0.46 \mathrm{~m})^{2}(0.24 \mathrm{~N}) 0.5}{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(28 \times 10^{-9} \mathrm{C}\right)}=1.01 \times 10^{-4} \mathrm{C}
\end{aligned}
$$

71. Static equilibrium will occur when the electric force of attraction is equal in magnitude to the weight of the lower sphere.

$$
\begin{gathered}
F_{E}=k \frac{\left|q_{1} q_{2}\right|}{r^{2}}=m g=(0.040)(9.81)=0.39 \mathrm{~N} \\
r=\sqrt{\frac{k\left|q_{1} q_{2}\right|}{F_{E}}}=\sqrt{\frac{\left(8.99 \times 10^{9}\right)\left(2.0 \times 10^{-6}\right)\left(1.0 \times 10^{-6}\right)}{0.39}}=0.21 \mathrm{~m}
\end{gathered}
$$

72. First, we find the magnitude of the repulsive force $F_{1}$ on charge $q_{3}=0.50 \mu \mathrm{C}$, due to charge $q_{1}=1.0 \mu \mathrm{C}$.

$$
\left|\overrightarrow{\boldsymbol{F}}_{1}\right|=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.0 \times 10^{-6} \mathrm{C}\right)\left(0.50 \times 10^{-6} \mathrm{C}\right)}{(0.10 \mathrm{~m})^{2}}
$$

The vector force is then

$$
\overrightarrow{\boldsymbol{F}}_{1}=\left[\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.0 \times 10^{-6} \mathrm{C}\right)\left(0.50 \times 10^{-6} \mathrm{C}\right)}{(0.10 \mathrm{~m})^{2}}\right]\left[\cos 60^{\circ} \hat{\boldsymbol{i}}-\sin 60^{\circ} \hat{\boldsymbol{j}}\right]
$$

The magnitude of the attractive force $F_{2}$ is the same as $F_{1}$, since the magnitude of the charges and their separation are the same.

$$
\overrightarrow{\boldsymbol{F}}_{2}=-\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.0 \times 10^{-6} \mathrm{C}\right)\left(0.50 \times 10^{-6} \mathrm{C}\right)}{(0.10 \mathrm{~m})^{2}} \hat{\boldsymbol{i}}
$$

Therefore,

$$
\begin{aligned}
& \overrightarrow{\boldsymbol{F}}_{\text {tot }}=\overrightarrow{\boldsymbol{F}}_{1}+\overrightarrow{\boldsymbol{F}}_{2}=\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right) \frac{\left(1.0 \times 10^{-6} \mathrm{C}\right)\left(0.50 \times 10^{-6} \mathrm{C}\right)}{(0.10 \mathrm{~m})^{2}}\left[\left(-1+\cos 60^{\circ}\right) \hat{\boldsymbol{i}}-\sin 60^{\circ} \hat{\boldsymbol{j}}\right] \\
& \overrightarrow{\boldsymbol{F}}_{\text {tot }}=(-0.22 \hat{\boldsymbol{i}}-0.39 \hat{\boldsymbol{j}}) \mathrm{N}
\end{aligned}
$$

73. (a) By symmetry, the $x$ components of the two forces are equal and opposite, so the net force will be the sum of the $y$ components.

$$
F_{y}=F_{1} \cos \theta+F_{2} \cos \theta=\frac{2 k Q q}{r^{2}} \cos \theta
$$

Using the Pythagorean theorem,

$$
r=\sqrt{h^{2}+a^{2}}
$$

and

$$
\cos \theta=\frac{h}{r}=\frac{h}{\sqrt{h^{2}+a^{2}}}
$$

Therefore,

$$
F_{y}=\frac{2 k Q q}{h^{2}+a^{2}} \frac{h}{\sqrt{h^{2}+a^{2}}}=\frac{2 k Q q h}{\left(h^{2}+a^{2}\right)^{\frac{3}{2}}}
$$

As a vector,

$$
\overrightarrow{\boldsymbol{F}}=\frac{2 k Q q h}{\left(h^{2}+a^{2}\right)^{\frac{3}{2}}} \hat{\boldsymbol{j}}
$$

(b) When $h \gg a$, the $a^{2}$ term in the denominator will be negligible.

$$
F_{y}=\frac{2 k Q q h}{\left(h^{2}+a^{2}\right)^{\frac{3}{2}}} \approx \frac{2 k Q q h}{\left(h^{2}\right)^{\frac{3}{2}}}=\frac{k(2 Q) q}{h^{2}}
$$

The result is equivalent to charges $q$ and $2 Q$, separated by a distance, $h$.
74. (a) To find the maximum, we set the derivative equal to zero.

\begin{aligned}
& \frac{d F_{y}}{d y}=\frac{\left(y^{2}+a^{2}\right)^{\frac{3}{2}} 2 k Q q-2 k Q q y\left[\frac{3}{2}\left(y^{2}+a^{2}\right)^{\frac{1}{2}} 2 y\right]}{\left(y^{2}+a^{2}\right)^{3}}=0 \\
& \left(y^{2}+a^{2}\right)^{\frac{3}{2}}=3 y^{2}\left(y^{2}+a^{2}\right)^{\frac{1}{2}} \\
& y^{2}+a^{2}=3 y^{2} \\
& y= \pm \frac{a}{\sqrt{2}}
\end{aligned}
$$

| (2) Sphere C: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{CA}}=-\frac{k q^{2}}{d^{2}+d^{2}} \frac{\hat{\boldsymbol{i}}+\hat{\boldsymbol{j}}}{\sqrt{2}}=-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{i}}-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{j}}$ |
| (3) Sphere D: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{DA}}=-\frac{k q^{2}}{d^{2}} \hat{\boldsymbol{i}}$ |
| (4) Sphere E: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{EA}}=-\frac{k q^{2}}{d^{2}} \hat{\boldsymbol{k}}$ |
| (5) Sphere F: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{FA}}=-\frac{k q^{2}}{d^{2}+d^{2}} \frac{\hat{\boldsymbol{j}}+\hat{\boldsymbol{k}}}{\sqrt{2}}=-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{j}}-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{k}}$ |
| (6) Sphere G: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{GA}}=-\frac{k q^{2}}{d^{2}+d^{2}+d^{2}} \frac{\hat{\boldsymbol{i}}+\hat{\boldsymbol{j}}+\hat{\boldsymbol{k}}}{\sqrt{3}}$ |
| (7) Sphere H: | $\overrightarrow{\boldsymbol{F}}_{\mathrm{GA}}=-\left(\frac{k q^{2}}{3 \sqrt{3} d^{2}}\right) \hat{\boldsymbol{i}}-\left(\frac{k q^{2}}{3 \sqrt{3} d^{2}}\right) \hat{\boldsymbol{j}}-\left(\frac{k q^{2}}{3 \sqrt{3} d^{2}}\right) \hat{\boldsymbol{k}}$ |
|  | $\overrightarrow{\boldsymbol{F}}_{\mathrm{HA}}=-\frac{k q^{2}}{d^{2}+d^{2}} \frac{\hat{\boldsymbol{i}}+\hat{\boldsymbol{k}}}{\sqrt{2}}=-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{i}}-\left(\frac{k q^{2}}{2 \sqrt{2} d^{2}}\right) \hat{\boldsymbol{k}}$ |

Notice that because of symmetry, the components of the field have the same overall magnitude. The force on Sphere A is

$$
\begin{aligned}
& \overrightarrow{\boldsymbol{F}}_{\text {tot }}=-\frac{k q^{2}}{d^{2}}\left[1+\frac{2}{2 \sqrt{2}}+\frac{1}{3 \sqrt{3}}\right](\hat{\boldsymbol{i}}+\hat{\boldsymbol{j}}+\hat{\boldsymbol{k}})=-\frac{\left(8.99 \times 10^{9}\right)\left(2.00 \times 10^{-6} \mathrm{C}\right)^{2}}{(0.500 \mathrm{~m})^{2}}(1.90)(\hat{\boldsymbol{i}}+\hat{\boldsymbol{j}}+\hat{\boldsymbol{k}}) \\
& \overrightarrow{\boldsymbol{F}}_{\text {tot }}=(-0.273 \hat{\boldsymbol{i}}-0.273 \hat{\boldsymbol{j}}-0.273 \hat{\boldsymbol{k}}) \mathrm{N}
\end{aligned}
$$

76. Higher. The electrostatic force is larger when they are closer, so the friction force, and hence the coefficient of friction, must be larger.
77. Since the sphere is in static equilibrium, the net force on it is zero.

$$
\begin{array}{ll}
\sum F_{x}=0: & F_{E}-F_{s, \text { max }}=k \frac{q^{2}}{r^{2}}-\mu_{s} F_{N}=0 \\
\sum F_{y}=0: & F_{N}-F_{g}=F_{N}-m g=0
\end{array}
$$

From the $y$ equation, $F_{\mathrm{N}}=m g$. Insert this into the $x$ equation, and solve for the coefficient of static friction.

$$
\mu_{s}=\frac{k q^{2}}{m g r^{2}}
$$

78. Applying the equation derived in Problem 77,

$$
\mu_{s}=\frac{k q^{2}}{m g r^{2}}=\frac{\left(8.99 \times 10^{9} \mathrm{~N} \cdot \mathrm{~m}^{2} / \mathrm{C}^{2}\right)\left(89 \times 10^{-9} \mathrm{C}\right)^{2}}{\left(7.5 \times 10^{-5} \mathrm{~kg}\right)\left(9.81 \mathrm{~m} / \mathrm{s}^{2}\right)(0.5 \mathrm{~m})^{2}}=0.39
$$

79. At the origin, the net force on $q$ is zero. When displaced a small distance, $x$, along the $x$ axis, there will be a net force towards the origin - a restoring force. The net force due to the two charges $Q$ is

$$
F_{x}=F_{2}-F_{1}=\frac{k Q q}{(a+x)^{2}}-\frac{k Q q}{(a-x)^{2}}
$$

This expression is zero for $x=0$, so we need to expand for small $x$. We can put this into a form to use the approximation,

$$
\begin{gathered}
\frac{1}{(1+\delta)^{2}} \approx 1-2 \delta \\
F_{x}=\frac{k Q q}{a^{2}}\left[\frac{1}{\left(1+\frac{x}{a}\right)^{2}}-\frac{1}{\left(1-\frac{x}{a}\right)^{2}}\right] \approx \frac{k Q q}{a^{2}}\left[-2 \frac{x}{a}-\left(+2 \frac{x}{a}\right)\right] \approx-\frac{4 k Q q}{a^{3}} x
\end{gathered}
$$

Equivalently, we can find a common denominator,

$$
F_{x}=k Q q \frac{(a-x)^{2}-(a+x)^{2}}{(a+x)^{2}(a-x)^{2}}=-k Q q \frac{4 a x}{(a+x)^{2}(a-x)^{2}}
$$

And then, when $x \ll a$, we can neglect it in the denominator.

$$
F_{x} \approx-\frac{4 k Q q}{a^{3}} x
$$

This is a linear restoring force with an effective "spring constant" $K$, that depends on the charges and the separation. By direct analogy with the mass-spring system of Chapter 16, the angular frequency of oscillation of the charge $q$ is given by Equation 16.26.

$$
\begin{gathered}
K=\frac{4 k Q q}{a^{3}} \\
\omega=\sqrt{\frac{K}{m}}=\sqrt{\frac{4 k Q q}{m a^{3}}}
\end{gathered}
$$
